SUBJECT: Declaring PHILIPPINE VALVE MANUFACTURING COMPANY as the Lowest Calculated Responsive Bid (LCRB) and to recommend to the Head of Procuring Entity (HoPE) the award of the contract for Lot B (Water Meter ½" dia. (15mm) Class B) of the Procurement of Materials for New Service Connection / PhilGEPS Ref. No. 9440143

WHEREAS, the Bids and Awards Committee (BAC) of Digos Water District conducted a competitive bidding for the Procurement of Materials for New Service Connection last March 1, 2023;

WHEREAS, Constech Asia Corporation was the Lowest Calculated Responsive Bid (LCRB) for Lots A and B of the said procurement project and was awarded with the contract;

WHEREAS, the water meters submitted by Constech Asia Corporation failed the standard Water Meter Accuracy Test;

WHEREAS, Constech Asia Corporation cancelled and waived the contract for Lot B (Water Meter ½" dia. (15mm) Class B) due to standard water meter test failure;

WHEREAS, Sec. 40.2 of the 2016 Revised IRR of RA 9184 provides that "In the case of the failure, refusal or inability of the bidder with LCRB... to enter into contract... the BAC shall disqualify the said bidder, and shall initiate and complete the post-qualification process on the bidder with the second Lowest Calculated Bid...";

WHEREAS, Constech Asia Corporation was post-disqualified and post-qualification of the next Lowest Calculated Bid (LCB), Philippine Valve Manufacturing Company, will be conducted;

WHEREAS, the BAC evaluated, verified, validated and ascertained all statements made and documents submitted, premised on the doctrine of fair play;

WHEREAS, PHILIPPINE VALVE MANUFACTURING COMPANY complied with and is responsive to the requirements and technical specifications required by the BAC for Lot B of the said procurement project;

WHEREFORE, after due deliberation, on motion of Ms. Aileen R. Banogbanog, and duly seconded by Ms. Aphrodite M. Adrales, it was;

RESOLVED, as it is hereby resolved, to declare PHILIPPINE VALVE MANUFACTURING COMPANY as the Lowest Calculated Responsive Bid (LCRB) for Lot B (Water Meter ½" dia. (15mm) Class B) of the Procurement of Materials for New Service Connection;

RESOLVED FURTHER, to recommend to the Head of Procuring Entity the award of the contract for Lot B (Water Meter ½" dia. (15mm) Class B) of the Procurement of Materials for New Service Connection to PHILIPPINE VALVE MANUFACTURING COMPANY with contract amount of One Million One Hundred Thousand Pesos (₱1,100,000.00) only.
